## GEOL 420/620 Lecture Lab course, Spring2016

Introduction to X-Ray Diffraction and X-Ray Spectrometry Methods

Learning Outcomes/ Course Objectives: Introduction to the principles and methods of x-ray analysis as applied to the study of minerals. Powder camera, diffractometry and spectrometry methods covered. Two hours lecture and six hours laboratory. This course is crosslisted with GEOL 620. Credit at the 600-level requires additional work. 4 credits. The purpose of this course is to train students in basic concepts of X-ray diffraction and spectrometric methods. At the end the students will be able to use diffraction data for identifying crystalline phases, evaluate their phase proportion, and refine simple structures. The students will also know which X-ray spectroscopic methods are available and how they are used for understanding properties such as valence and local coordination of ions. Basic concepts of structure description and symmetries of crystals are discussed also. The students are are required to submit written homework assignments and pass a final examen which includes a lab section.

Grades will be based 50% on the homework evaluations and 50% on the final examen.

<u>Assessment:</u> Grades will be based 50% on the homework evaluations and 50% on the final examen. Grades: A: = 100-90 %; B: 89-80%; C: 79-70%; D: 69-60%, F: <60% I assign +/- grades for scores that are 2.5 points above or below the break between each letter grade.

<u>Attendance Policy:</u> Absence from 3 or more of the regular classes will result in an automatic grade of "F" for the class.
