2. Course Learning

Upon completion of the course, students should have a comprehensive, introductory understanding of:

- 2. Groundwater definitions and properties
- 3. Principles of Groundwater flow
- 4. Regional Groundwater flow
- 5. Geology of Groundwater
- 6. Groundwater flow to wells
- Well drilling and construction
- 8. Well logging and sampling
- 9. Water Quality and Groundwater Pollution
- 10. Introduction to Groundwater modeling
- 11. Surface Water Considerations (time permitting)
- 3. Assessment of these learning/outcome objectives will be based on lecture, quizzes, term assignments, and exams including the final exam.
- 4. The purpose of this course is to provide an introduction to and survey of the field of Hydrogeology. Student responsibilities include: attending the lectures, taking and maintaining lecture notes to supplement the assigned text readings and webinars, studying and learning the hydrogeological terms, relationships, field approaches and basic quantitative methods. Examinations are primarily multiple choice, key-term definition and problem solving; Departmental policy precludes make-up exams.
